Bawinanga Aboriginal Corporation (Special Administrators Appointed)

Circular to suppliers

As you may be aware, Tony Jonsson and myself were appointed as joint and several Special Administrators to the Bawinanga Aboriginal Corporation ("the Corporation") by the Registrar of Indigenous Corporations at 11:59pm (CST) on Thursday 26 December 2013 pursuant to section 490-1 of the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* ("the CATSI Act"). A copy of our notice of appointment is *enclosed* for your reference.

Under the terms of our appointment, the Corporation is continuing to trade therefore please amend your present account to reflect our appointment.

Any creditors who claim title to any asset of the Corporation should contact us in writing with substantiating details as a matter of urgency and we will then consider any such claim.

In our capacity as Special Administrators, we are not liable for any debts incurred by the Corporation prior to our appointment. During the period of our appointment, any further credit properly incurred by the Corporation will represent a liability of the Special Administrators.

To this end, no further credit should be extended to the Corporation without an order signed personally by either Tony Jonsson or myself as Special Administrators, or one of the authorised personnel whose specimen signatures appear on the *enclosed* schedule. Any new credit extended to the Corporation under these arrangements should be in the name of Bawinanga Aboriginal Corporation (Special Administrators Appointed).

Payments made by us must be applied against this debt and cannot be applied against any debts associated with the Corporation prior to our appointment. Payments may only be applied against debts incurred before the date of our appointment where the payment is accompanied by written instructions signed by two authorised personnel to that effect.

Please also note:

- under the Pay As You Go (PAYG) regime we will be obliged to withhold 48.5% from payments to suppliers who do not quote a current Australian Business Number (ABN). Please ensure that a current ABN is quoted for each supply made by you.
- Input tax credits for payments made to registered suppliers cannot be claimed until such
 time as a compliant tax invoice has been received. Accordingly, we expect suppliers to
 provide a GST compliant tax invoice prior to payment for supplies you make to the
 associated incorporation.



We will report further to creditors as soon as possible in relation to existing debts. In that regard it is our expectation that any debts incurred during the period of the previous Special Administrators' appointment will be met in full in the foreseeable future, and that subject to our clarification of the Corporation's financial position and the documentation submitted by the creditors to the previous Special Administrators, creditors owed monies on or before 30 October 2012 will receive 70 cents per each dollar owed in full settlement of such debts.
