#### NOTICE OF EXTENSION OF THE PERIOD OF SPECIAL ADMINISTRATION OF THE ADNYAMATHANHA TRADITIONAL LANDS ASSOCIATION (ABORIGINAL CORPORATION) RNTBC AND THE PERIOD OF APPOINTMENT OF SPECIAL ADMINISTRATOR

##### WHEREAS:

On 25 March 2020, a delegate of the Registrar of Aboriginal and Torres Strait Islander Corporations (**delegate of the Registrar**) determined under section 487-1 of the *Corporations (Aboriginal and Torres Strait Islander) Act 2006 (CATSI Act)*, that Adnyamathanha Traditional Lands Association (Aboriginal Corporation) RNTBC (ICN 3743) (**the corporation**) would be placed under special administration from 12:01am (ACST) on Thursday, 26 March 2020 until 11:59pm (ACST) on Tuesday, 30 June 2020.
- B. On the same day, under section 490-1 of the CATSI Act, the delegate of the Registrar appointed Mr Bevan Mailman and Mr Brian Bero as the joint and several special administrators for the period of the special administration.

- H. On 20 April 2021, under subsections 487-15(1) and 490-5(2) of the CATSI Act, a delegate of the Registrar extended the special administration until 11:59pm (ACST) on Wednesday, 30 June 2021 and appointed of Mr Peter McQuoid as the special administrator.

- I. On 28 June 2021, under subsections 487-15(1) and 490-5(2) of the CATSI Act, a delegate of the Registrar extended the special administration until 11:59pm (ACST) on Friday, 31 December 2021 and appointed of Mr Peter McQuoid as the special administrator.
