We were appointed after the Registrar found some issues with the corporation's governance and money story—which YAC has been unable to fix. Our appointment is a 'special measure' under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006*—to protect the rights of members and common law holders. It means we take control of the corporation, work to resolve its issues, and return it to the members' control.

An information meeting will be held as follows. All members and interested parties are welcome. Please note that members will **not** be paid to attend. A representative of the Registrar will be present to answer questions. **No media** will attend.
